We will work to ensure that all products that WCN produces, trades or processes are in line with these commitments.

Our commitments and for all third-party suppliers:

a. Commitments for all third-party suppliers of palm oil:

- No conversion and no new development from High Carbon Stock (HCS) and High Conservation Value (HCV) areas.
- Enforcement of a no-burning policy
- No new development on peat areas regardless of depth
- Best Management Practices for existing plantations on peat
- Follow best management parties for agricultural production and minimize use of pesticides and herbicides and prohibit use of paraquat
- Respect the Rights of Indigenous and Local Communities to give or withhold their Free, Prior and Informed Consent (FPIC) to Operations on Lands to Which They Hold Legal, Communal or Customary Rights
- Support the inclusion of smallholders into the supply chain.



b. Commitments for Wahana Citra Nabati and for all thirdparty suppliers

- No exploitation of workers and and local communities. Uphold and promote United Nations Universal Declaration on Human Right.
- Respect and recognize the rights of all workers including contract, temporary and migrant workers
- Uphold the right of all workers, regardless of rank or job grade, to form and join trade unions of their choice, and to bargain collectively
- Pay all workers the statutory monthly minimum wage and overtime compensation, in accordance with the current labor regulations.
- Provide fair and equal employment opportunities for all employees, regardless of race, religion or gender
- Promote safe and healthy working environment and provide workers with adequate equipment and training to ensure that workers are protected from exposure to occupational health and safety hazards
- Prohibit child labour and take appropriate measures to prevent child labour.
- Prohibit forced labour, bonded labour and human trafficking are not used or promoted, and take appropriate measures to prevent the use of such labour.
- Implement policies to prevent and remediate harassment and abuse, including sexual harassment and abuse

- Recruitment practices are transparent and fair, and direct recruitment is encouraged and recruitment process is well documented. Prohibit any retention of identity documents unless required by law.
- Assess social impacts from company operations, prevent and mitigate any negative socials impacts, and enhance positive impacts in form of coherent Corporate Social Responsibility (CSR) Programs or other
- Enable all workers access to judicial remedy and to credible grievance mechanisms without fear of recrimination or dismissal
- Adherence to all relevant laws

- Minimizing the carbon footprint of our operations and encourage reduction of GHG emissions in the supply base
- Identify and mitigate environment effects with aiming to minimize environment impacts
- Implement water management and monitoring plans for reducing impacts on water quality and water consumption


Early step to achieve goals of sustainable palm oil, our company to be a member of the RSPO and implement RSPO supply chain system in 2010 that are supported with a good team of our right employees. For this time, the global target of sustainable palm oil increased and we must continue to improve our planning to achieve our goals in fully sustainability based on SDGs of United Nation 2015.

We provide the Time Bound Action Plan in 2018 that is our project as guidance to achieve target fully sustainability until 2020. Our sustainability team works step by step to realization program to success toward fully sustainability of palm oil.

Traceability and Transparency

Traceability is a part of sustainable sources in our sustainability journey. We had identified palm oil sources can traceable to mills (TTM) until 100% in 2019. The key criteria in our TTM approach are:

- ✓ Parent Company Name of Mill
- ✓ Mill Name
- ✓ Mill Address
- ✓ Coordinates of Mills



Next step, moving forward to traceable of 100% palm oil sources until plantations in 2020. In the running to achieve 100% palm oil traceability to plantations (TTP), we had achieved progress until 88% TTP of palm oil in 2019. The key criteria our TTP approach are:

- ✓ Estate Name
- ✓ Village of Estates
- ✓ Coordinates of Estates

We believe that feedback from stakeholders is valuable for our business. It helps us to monitor own performance with comply in our sustainability commitment and also our palm oil supplier. All grievances will we be handled in accordance to Grievance Procedure and report transparently to public.



As a member RSPO, we are committed to transparency in our sustainability program to submit RSPO Annual Communication on Progress (ACOP).

Suppliers Engagement

CORE (Proforest and Daemeter) greatly helps us to improve our sustainability project. Our priority is engaging suppliers as part our sustainability journey, we look importance suppliers to support successful our target, include environmental, labor and social issues.

Our approach engagement includes :

- Conducting workshop with suppliers, where we help them to understand our sustainable palm oil policy and requirements to ensure compliance.
- Share questionnaire sustainability to filled by suppliers, where we help them to assess progress sustainability themselves.
- Visit to mill to identify gaps of sustainability requirements. In early 2020, we visited one mill of our suppliers to conduct assessment sustainability.

Water Management

- ✓ Install the Reverse Osmosis System with target to fully recycle treated water (result the waste water treatment) that used for input boiler water.
- ✓ Conduct the water conservation with establish the wells to infiltration the rainwater onto to earth.

Energy Effeciency

At WCN, we are aware that increasing carbon footprint can be effect to environment. So that, we responsible to calculate our GHG emissions, identify the key emissions sources and have plan to reduce the our GHG emissions. Our strategy to reducing GHG emissions in our production through:

- ✓ Change lamp in our production with LED

- ✓ etc



 PT. Wahana Citra Nabati has been an active member of RSPO since year 2010. Our refinery is certified under RSPO Supply Chain Certification System (SCCS) by TUV Rheinland. Categories of supply chain models of certified our palm oil products are Segregation (SG) and Mass Balance (MB).
- Quality Management System ISO 9001: 2015
 PT. Wahana Citra Nabati implement the quality management system (ISO 9001: 2015) to assure the quality products meet customers requirement and legislation. By implementing this system, we aware to conduct continuous

improvement to increase productivity and improve product quality.

- Food Safety Management System FSSC 22000




Health and Safety
